Mercy Medical Center is a designated treatment center for sexual assault and domestic violence in Baltimore City. It has 30 specially trained Forensic Nurse Examiners (FNEs) available 24/7 to care for victims of sexual assault, and victims of domestic violence of all LGBTQ+ identities (including men, women, non-binary, and transgender individuals). The Forensic Nurse Examiner Program practices inclusive care and works collaboratively with criminal justice agencies and other Baltimore agencies addressing the needs of victims of violence regardless of how they identify.
